Meaningful consultation with community members has been an ongoing process for Tomorrow's Leadership Collaborative (TLC) Charter School and integral to the decisions made in response to COVID-19, with the development of the multiple school plans including – 2021-22 LCAP, Learning Continuity & Attendance Plan, AB 86 ELO Plan, SPSA, Return to in-person instruction School Plan, and this plan. As our school expands to serve additional grades across two school sites, engaging our community members is critical to our school's success.

The Administrative Leadership Team including the Associate Principal, met with the Special Education Administrator (Executive Director) during weekly Leadership meetings, staff development meetings, and planning meetings in preparation for the 2021-22 school year that included a review and analysis of multiple forms of schoolwide and student data in order to determine which prevention and mitigation strategies to implement in order to address the academic and social-emotional impact of lost instruction time. The Executive Director (Special Education Administrator) also meaningfully consulted with Disability Rights Organizations; and Advocates for Students with Disabilities that include the El Dorado Charter SELPA, the National Center for Special Education in Charter Schools, and the CHIME/WISH Charter Network.

Teachers, Paraprofessionals (other educators and classified staff were meaningfully consulted during staff meetings and were also surveyed to ensure public input in the development of this plan.

Students were meaningfully consulted through surveys, to identify their concerns and priorities. TLC families/guardians were consulted during Coffee with the Principal meetings, English Learner Advisory Committee (ELAC) and Parent Advisory Committee (PAC), including families of Unduplicated Pupils (English Learners, Low-income, Foster Youth) and families of Students with Disabilities (SWD). To provide all families with opportunities to provide public input, TLC administered a parent survey that was available in English and Spanish to ensure families that speak other languages were also consulted. For all parent/family/guardian meetings, interpreter services are provided and available upon request. Accommodations as appropriate are made for family members

with disabilities including providing information and school reports in a format (to the extent practicable) in a language that parents understand.

TLC Charter School evaluated its community member engagement opportunities and determined that Tribes, Civil Rights Organizations and Individuals or advocates (other than parents/families) representing interests of English Learners, Homeless, foster youth, migratory students, children who are incarcerated and underserved students were neither present nor currently served by the school except for parents/families representing these interests who were consulted (as noted earlier).

#### A description of how the development of the plan was influenced by community input.

As stated earlier with the development of the numerous school plans, and with the return to in-person instruction, community input has been instrumental and influential in the development of each of these plans. The development of this plan involved the compilation of input and feedback from each community member, and an analysis of schoolwide and student data. All of which focused on determining prevention and mitigation strategies to address the academic impact of lost instructional time, including the implementation of evidence-based interventions and strategies, in alignment with our school's Multi-tiered System of Supports (MTSS), Comprehensive Needs assessment, to address the academic, social-emotional, and mental health needs of our students, in addition to Health & Safety protocols.

The following is a summary of the key input that emerged from the meaningful consultation with community members:

- Provide extended learning opportunities – students in early grades, English Learners & Students with Disabilities
- Academic intervention built into the instructional day
- Paraprofessionals are essential for the return to in-person instruction as a result of school disruptions since March 2020
- Recess and Sports equipment
- Ensure a safe & health learning environment at both sites – PPE
- Mental Health wraparound services including food distributions for families experiencing food insecurity and Wi-Fi hotspots
- Bilingual Paraprofessional Coordinator – who conducts a needs assessment for families especially low-income and English Learners; and connects with community-based organizations to provide services for our students and their families.

TLC Charter School’s ESSER III Plan was significantly influenced by community input and focuses on the following areas:

- Continuous & Safe In-person Learning: ensuring PPE is provided at both sites to reduce the risk of virus transmission
- Addressing the Impact of Lost Instructional Time – providing Paraprofessionals to serve our EL and SWD
- Remaining Funds: Technology & Bilingual Outreach and Attendance Coordinator

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021, and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

## Fiscal Requirements

    - **Tier 2 – Moderate Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented quasi-experimental studies.
    - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
    - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Purchasing supplies to sanitize and clean the facilities of an LEA, including buildings operated by such agency;
  - Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;
  - Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
  - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
  - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
  - Addressing learning loss among students, including underserved students, by:
    - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
    - Implementing evidence-based activities to meet the comprehensive needs of students,
    - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
    - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;

- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.

- Any other strategies or activities implemented with the LEA’s ESSER III fund apportionment consistent with section 2001(e)(2) of the ARP Act; and
- Progress monitoring to ensure interventions address the academic, social, emotional, and mental health needs for all students, especially those students disproportionately impacted by COVID-19

## **Planned Actions and Expenditures**

### **Purpose and Requirements**

As noted in the Introduction, an LEA receiving ESSER III funds is required to develop a plan to use its ESSER III funds to, at a minimum, address students’ academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

### **Instructions**

## **Ensuring Interventions are Addressing Student Needs**

The LEA is required to ensure its interventions will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students most impacted by the COVID–19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.

For example, if an LEA plans to monitor the progress of two actions in the same way and with the same frequency, the LEA may list both actions within the same row of the table.
